SECTION 4. FIRST AID MEASURES

Inhalation:

Immediately remove from the area to a fresh air environment. Individuals showing evidence of inhalation exposure should be taken to an uncontaminated area. Obtain medical advice immediately.

SECTION 5. FIREFIGHTING MEASURES

Environmental precautions:

Methods and materials for containment and cleaning up:

Precautions for safe handling:
